^dIn reports published prior to July 2024, this grouping was titled "Tax Determined, Premises Use" and was comprised of amounts reported in cell 15(b) of the Brewer's Report of Operations (TTB F 5130.9) and line 10 of the Quarterly Brewer's Report of Operations (TTB F 5130.26). This field still represents the same amounts, but has been renamed to reflect that removals reported in line 10 of the Quarterly Brewer's Report of Operations may be in cans or kegs, and on or off premises.
